Northern Colorado Weavers Guild invites all fiber artists to participate in our 36<sup>th</sup> annual juried exhibit, Fiber Celebration 2010. We appreciate all past participants and hope you will consider entering again, and we also encourage submissions from new entrants.

Pieces representing fiber media of all types are welcome, including weaving, spinning, dyeing, basketry, sculpture, felting, quilting, papermaking, knitting, crocheting, and embroidery.

## **Timeline**

February 12, 2010	Postmark deadline for entries
March 31, 2010	Juror decisions
May 31, 2010	Deadline for delivery of items to gallery
June 4, 2010	Opening reception, awards presentation 5:00 to 7:00 PM
July 12, 2010	Pick up hand delivered items

## **Eligibility**

All fiber artists may submit up to three (3) items. All items must be original, not executed under supervision, and completed within the last two years. Misrepresented items will be returned.

## **Categories**

*A. Functional Two & Three Dimensional* - Household pieces meant to be used, such as rugs, coverlets, table linens, handspun yarn (for handspun yarn, state use).

*B. Non-Functional Two Dimensional* - Flat pieces emphasizing decorative expressive ideas.

*C. Non-Functional Three Dimensional* - Pieces designed to occupy space, emphasizing decorative or expressive ideas.

*D. Wearable* -Garments or yardage designed to be worn (for yardage, state use).

All pieces must be less than 4 ft. x 5 ft. when hung. Judging will be based on aesthetics, originality, craftsmanship, and suitability of technique and materials. If functional, the piece will also be judged on its appropriateness to purpose. The juror reserves the right to reclassify the piece if needed.

### **Non- Refundable Entry Fee**

NCWG members: \$14.00 per item.

Non-NCWG members: \$17.00 per item.

Make checks payable to NCWG.

### **Entry Submission**

Entrants must submit a CD with two (2) images in JPG format per item, one showing the overall piece and the other showing close-up detail so that technique can be seen (spinners may submit two yards of handspun yarn in lieu of pictures). Name each digital image file with the category letter, entry number, your name, title, and image number. (Example of entry file name: B1 Jane Doe title 1.jpg). CDs will not be returned. **Entry submissions must be postmarked by February 12, 2010.**

The juror and Tointon Gallery retain the right to disqualify any work from the exhibit that is unacceptable or that differs greatly from the entry images.

### **Juror**

The juror will be Linda Ligon, Founder and Creative Director of Interweave Press, and a founding member of Northern Colorado Weavers Guild.

### **Shipping**

If your entry is selected, you will receive further information about shipping or hand-delivering the item. In general, you will be responsible for delivery of the item to the Tointon Gallery, as well as assisting with arrangements for its return. Items must be ready for hanging or display and when necessary directions for installation must be provided.

### **Awards**

Awards will be given at the juror's discretion and will be presented during the opening reception, June 4, 2010, 5:00-7:00 PM.

### **Liability**

Waiver: All entries will be handled with utmost care. Exhibits are insured by the Union Colony Civic Center/City of Greeley during the run of the exhibit including hanging and taking down. Artists are responsible for insurance during shipping to and from the Gallery. Neither NCWG nor Tointon Gallery is responsible for deterioration or damage during shipping.

Tointon Gallery must have insurance values on all pieces exhibited. If you choose, your work may be placed for sale. **Tointon Gallery will retain a 30% commission on all sales.**

Juror accepted pieces must remain for the duration of the show.
